## Projects

**Growing Informal Cities Project:** This project examines the connections between urbanization, the growth of transnational informal economies and migrant entrepreneurship in South Africa (Cape Town and Johannesburg), Zimbabwe (Harare) and Mozambique (Maputo). Partners include the African Centre for Cities (UCT), Gauteng City Regional Observatory (GCRO), Eduardo Mondlane University and the International Migration Research Centre (IMRC). It is funded by the IDRC.

**Countering Xenophobia Project:** This builds on SAMP's work in documenting and contesting all manifestations of xenophobia in Southern Africa. SAMP has conducted regular attitudinal surveys of South Africans since the mid-1990s. With the upsurge in xenophobic violence, SAMP is planning another round of surveys. Funders are CIDA (Canada), DFID, OSISA and IDRC.

**Diasporas and Development Project:** SAMP plays a dominant role in global debates about the role of diasporas in development in Africa. It has recently conducted major research on the Southern African diaspora in Canada, Zimbabwean diaspora in South Africa and health worker migration and return. Funders are the IDRC, OSISA and CIHR.

**ACP Migration Observatory:** SAMP is a partner in the Migration Observatory of the African, Caribbean and Pacific Group of States. It has collaborated in research projects in Lesotho, Kenya and Nigeria and trained officials from 12 pilot countries in the ACP. It is funded by the IOM and EU.
